




# The Economic Benefits of Reducing the Dropout Rate for Students of Color in the Houston Metropolitan Area

In the Houston, Texas metropolitan area, which includes the city itself and ten surrounding counties, students of color made up a sizable portion of the estimated 26,900 students who dropped out from the Class of 2008: **4,250 African American, 14,000 Latino, 100 American Indian, and 1,000 Asian American<sup>1</sup> students are estimated to have dropped out from this class.**

Cutting the number of these dropouts in half would likely produce vast economic benefits by boosting the spending power of these communities of color and spurring job and economic growth in the Houston area. Below, see the likely contributions<sup>2</sup> that these “new graduates” would make to their regional economy.

	<b>Increased Home and Auto Sales</b>	New graduates' increased spending would likely result in increases in the total value of homes purchased by the midpoint of their careers and the amount of money spent on vehicle purchases in an average year:	\$49.2 million (homes); \$1.6 million (autos)	\$160.6 million (homes); \$5.2 million (autos)	\$900,000 (homes); \$30,000 (autos)	\$16.2 million (homes); \$400,000 (autos)

All told, the students of color within this one class of new graduates could produce enormous benefits for the local economy:

- ✓ Together, their additional spending would likely generate **950 new jobs** and boost the gross regional product by as much as **\$181.2 million** by the time they reach the midpoint of their careers.
- ✓ As a result of their increased wages and higher levels of spending, state and local tax revenues within this metro area would likely grow by as much as **\$12.7 million** during an average year.
- ✓ The region would likely see increased human capital, with **46 percent** of these new graduates likely continuing on to pursue some type of postsecondary education after earning a high school diploma.

<sup>1</sup> For this analysis, figures for Asian American students are aggregated and include Pacific Islanders and Native Hawaiians. Though the Asian American community is particularly diverse, disaggregated data is not available for the numerous ethnicities included within it.
